12:00 pm – 5:00 pm. Event will be operational rain or shine (vendors should prepare for all conditions). Vendor check in starts at 10:00 am at the Vendor check in booth to obtain your package and site number. Exhibitors must be set-up by 11:30 pm and remain set up until 5:00 pm.

Fees

Vendor Fee - 35.00, Non-profit organizations with educational display-no charge, Non-profit selling products a \$20.00 fee is applicable.

Area of Operation

Limited vending space is available this year at the Marina. Vendors will be assigned a specific vending space by event organizers at time of check in.

Exhibitor Set-up

Exhibitors get a 10 x 10 space and are responsible for their own tent, chairs, tables, electricity and electrical equipment such as extension cords. Each exhibitor is required to keep their space and surrounding area clean and remove all trash at the end of the day. Recyclable waste must be deposited in the proper receptacles provided (i.e. plastic and aluminum cans). Special requests like electricity requirements should be done so at the time of submitting application. We will do our best but not all requests can be guaranteed.

Security

Law enforcement personnel will be present at this year's event for the safety of our vendors and guest.
